Erik Ilyayev, MD

Dr. Erik Ilyayev was the founder and original CEO of MyHouseVisit.com - an organization that provides medical home visits to the elderly and home-bound. The team of physicians, nurses, and care coordinators have serviced more than 5,000 patients in the New York metropolitan area. In Early 2021, MyHouseVisit.com was acquired by ConcertoCare. He also served as the regional medical director of hospice for the Visiting Nurse Service Of New York, which is the largest not-for-profit home- and community-based health care organization in the nation.

Being very passionate about medical education, he holds academic appointments as Associate Professor of Medicine in Touro College, St. Georges Medical University, and is the Vice Director of Undergraduate Medical Education for Kingsbrook Jewish Medical Center.

Seeing the complexity of chronic disease and the opportunity for optimized coordination of care, Dr. Ilyayev cofounded iKonnnect.io, a technology platform, that delivers care coordination to more than 5,000 patients.


